Recreation Committee Meeting Wednesday, May 19, 2010 4:00 p.m. District Office

Committee Member, Mike Garvey, called the meeting to order.

Members Present: Michael Garvey, Tina Roehl, Kellie Loeb, Mark Lemminger (arrived at 4:25 p.m.)

Member Absent: Tom Kupsche.

Also Present: Recreation Director, Jim Braunschweig, Jessica Schleicher, and Andrew Swanson.

Dr. Garvey verified that the meeting was properly posted.

Motion by Roehl/Loeb to adopt the agenda as posted. Motion passed.

Motion by Garvey/Roehl to select Mark Lemminger as Chair.

Dr. Garvey presented the current financial reports and a copy of the original resolution. Mr. Braunschweig gave his report which included:

- 94 kids are participating in Spring Soccer. The final day is Saturday, May 22, 2010. Fall dates have been set and registration sheets will be available at Saturday's soccer game.
- Jim is working on the website.
- Jim has submitted information for the newsletter. A Recreation survey will be included.
- Jim has been coordinating activities with the Senior circle.

## Mr. Lemminger arrived.

- Jim is interested in developing volleyball courts possibly at Centennial Park. Mr. Lemminger suggested Jim attend the next Village Board meeting. Dr. Garvey indicated that the poles and nets can come out of the Recreation program.
- Dr. Garvey and Mr. Braunschweig have been approached by Randy Roehl about transitioning the Johnson Creek youth football program to the Recreation program. Jim will keep us informed.

Mr. Lemminger assumed the Chair.

Dr. Garvey reviewed the financial report and explained the purpose and structure of the Recreation Committee. He pointed out that the Village is to pay their contribution to the Fund by January 31 each year. He asked Mr. Lemminger to check on this since the school records indicate the payment has not been made for 2010 (\$6500).

Mr. Braunschweig and Dr. Garvey have been discussing the After Summer School program with Jessica Schleicher, a teacher at the Elementary School. Jim recommended that Mrs. Schleicher be hired as the Program Director for this summer. Dr. Garvey recommended an \$1100 salary based upon \$15/hour.

Motion by Roehl/Garvey to hire Jessica Schleicher as the After Summer School Program Director.

Roll call vote: Roehl – Y, Loeb – Y, Garvey – Y, Lemminger – Y Motion passed 4-0 with Mr. Kupsche being absent.

Mrs. Schleicher gave a detailed presentation of the program she will be offering.

The Committee confirmed that she could fill two student staff positions with additional students hired as needed.

Mr. Braunschweig indicated that a survey would be in the Spring newsletter. He encouraged committee members to steer questions and ideas to him.

Future ideas include adult volleyball, adult softball, bean bags and kickball.

Motion by Roehl/Loeb to adjourn. Motion passed.
