Dr. Garvey called the meeting to order.

Members Present: Michael Garvey, Tina Roehl, Kellie Loeb, Tom Kupsche, and Tim Semo.

Also Present: Recreation Director Jim Braunschweig, After Summer School Coordinator Jessica Schleicher

Dr. Garvey verified that the meeting was properly posted.

Motion by Loeb/Kupsche to adopt the agenda as posted. Motion passed.

Select Chair: Motion by Kupsche/Loeb to elect Tim Semo chair of the Recreation Committee. Motion passed.

Director's Report: Mr. Braunschweig presented survey results from the Spring Recreation Survey. The number returned was low but the Committee felt the responses reflected the comments they individually have been receiving.

The Committee discussed possible 2010-11 offerings. Mr. Braunschweig will have interest sign-up forms at school registration for:

- Fall adult volleyball
- Crafts (Pottery, Scrapbooking and Stamping, Basket weaving)
- Chess Club
- Spring horseback riding
- Summer softball

Recreation staff will also handle soccer sign up at registration.

Mr. Braunschweig will contact Loeb Metals to arrange pick up of the volleyball standards they are donating.

Mr. Braunschweig will contact the Village Administrator as to the location of the volleyball court.

Mr. Braunschweig will contact the DNR to possibly offer a hunter safety course through the Recreation Program.

Jessica Schleicher presented her report about the After Summer School Club. Although a success, the number of participants continues to be low. The Committee encouraged Mr. Braunschweig to do more publicity about all of the programs including a separate Recreation Newsletter.

The Committee discussed equipment and materials needed for this year.

Motion by Garvey/Kupsche to purchase portable regulation soccer goals, materials necessary to build an ice rink (pending village approval), and volleyball nets. Motion passed.

Mr. Kupsche will meet with Mr. Johnsrud to request permission to build a skating rink in Veteran's Park.

Mr. Kupsche and Mr. Semo will approach a local business owner about sponsorship of the soccer goals.

The Committee discussed the importance of the School/Village partnership continuing. Mr. Kupsche informed the Committee that the proposed Village budget contained \$7000 for the Joint Recreation Program. Mr. Kupsche and Mr. Semo agreed to continue to advocate for the program.

The Committee discussed the fees that have been proposed by Village Administrator Mark Johnsrud which would be imposed on recreation participants. The Committee unanimously opposes charging recreation or school participants to use the parks.

Mr. Braunschweig was authorized to hire appropriate staff for soccer and other programs as necessary. Dr. Garvey will work with him on this.

Motion by Roehl/Kupsche to adjourn. Motion passed.
