Regular Board of Education Meeting Minutes Tuesday, October 27, 2009 6:00 pm Elementary Music Room

A suggestion was made to have the school computer lab available for residents to fill out the survey on-line. The projected date to mail the survey to all District residents is November 16, 2009.
