C. Superintendent Update

Reported on the status of immunizations in the district. Only one student remains in need of immunizations for this school year. The Board will meet next week to set the tax levy. Even though the School District lost \$12 million in property value, the Village increased \$5 million. This will result in a shift of tax responsibility within the District.

D. Principal Reports

Kris Blakeley reported that parent/teacher conferences were going on at present. Red Ribbon Week is going on this week. There are two student teachers in the Elementary building. The Elementary students will be holding a Coats for Kids project. Sixth grade will be developing service learning skills by working with the special Olympics in our area.
