Conduct the Annual Budget Hearing

Mr. Siewert appointed Rebecca Stewart to be the secretary of the Budget Hearing and Annual Meeting.

State of the District 2018

Dr. Garvey gave his annual State of the District report. During his report he stated:

- "Student population continues to increase.
- We are half way through with our athletic fields' project and half way through with our fundraising. We will need to hit fundraising hard again this year.
- Over the past ten years, we have seen a tremendous change in curriculum and our
 instructional practices. As you know, these changes have been the result of very hard
 work by our staff and students. Over this time, we have seen full implementation of
 personalized learning. Students are showing incredible progress on our MAP tests. We
 have increased the number of AP courses we offer and our students are being more
 successful than ever before.
- We continue to have districts visit our buildings to see personalized learning in action. Through work with UW-Madison we are gaining national attention.
- As we have done in the past with our paraprofessionals becoming teachers, we promoted instructional staff from within. We welcomed Melissa Enger as our new elementary school principal straight out of 11 years as a kindergarten teacher in the District. We moved another kindergarten teacher into the role of Innovations/Media Specialist placing Mr. Cheek in a position to oversee our Libraries and Flex Learning Centers. Stacy

Pustina who joined, our staff last year as the school Psychologist, had her responsibilities increased as she became our Director of Pupil Services."

Budget Review

Dr. Garvey stated the 2018-19 proposed budget:

- Continues to update the curriculum and instructional practice.
- Supports instructional practices that promote individualized instruction so that every student meets his or her potential.
- Continues financial health of the District.

Dr. Garvey reviewed the Budget.

Dr. Garvey explained the revenue limit process. He also reminded Board members that even though the Annual Meeting will set an advisory levy, by statue, the final levy must be set by November 1st, by the Board.

Mrs. Enger and Dr. Garvey met with her UW Supervisor and her grad classes start back up on Friday. Picture day for the Elementary was today.

Mrs. Krohn mentioned the last week of August she met with teachers and set schedules. A reporter from Milwaukee Public Radio visited to do a story on Personalized Learning and to

complete follow up research for National Public Radio. NPR is doing a piece on Personalized Learning with Johnson Creek being part of their report. She is beginning to bring in fall student data with the start of MAP testing last week.
