1. The Covid-19 virus impacted the start dates and the number of participants in baseball and softball.
2. Participation totals after withdrawals were 59 and 23 respectively.
3. Twenty-three baseball and six softball players chose not to play.

September/October 2020-2021 School Year

Activity: All – 70 Participants.

1. Soccer fields at Bell Park have been reconfigured for practice.
2. Twenty-one children compete in soccer at Lake Mills every Saturday.
3. Six children at the 4K level are having fun learning and practicing soccer at Bell Park each week.
4. This fall girls are playing outdoor “grass” volleyball competing with other teams from the Watertown YMCA. The recreation department is fielding three teams. Practice is at Centennial Park. Games are in Watertown.

5. Grade levels 1-2 and 3-4 have been competing in the NFL Flag Football Program. They wear NFL football apparel and compete against Lake Mills teams.
6. Grades 5-6 compete in a Traveling Passing Only League against other teams from Lake Mills.
7. All home games are played at Wendt Field located by the elementary school. Two Johnson Creek high school students are officiating the home games.

Yoga will now be held every Wednesday evening. ESY Basketball league rules have yet to be released. JC Has offered to host league games. Waterloo has agreed to host the entire league. Mr. Hayes expects decisions to be made by October 1st.
