Motion by Johnson to add the following language to the Nepotism Section in the Employee Handbook:

A.1 No person related to the superintendent by affinity or consanguinity shall be eligible for employment *in a regular position*, by the district.

A.2 No person related by affinity or consanguinity to other administrators shall be eligible employment *in a regular position*, in the areas which those administrators supervise.

A.3 No person related to a school board member by affinity or consanguinity shall be eligible for employment *in a regular position*, by the district.

Regular position as it is used in this section does not include subbing, summer school positions, student summer maintenance positions, or recreations positions.

There was no second. Motion failed.

Motion by Kolaske/Hartz to send the Nepotism language to the WASB attorney for review and a legal opinion asking if the proposed language is legal and if the language is consistent throughout the section in the handbook.
