She pointed out that this and other events hosted by Ms. Norby in the past have had direct ties to the national conservative organization Moms for Liberty, which advocated against the rights of LGBTQ+ youth.

Shall the School District of Johnson Creek, Jefferson County, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statues, for up to \$2,500,000 non-recurring for 4 years, starting with the 2024-2025 school year, to maintain ongoing operational expenses, technology, safety, and educational programming.
