## **Resolution B: School Food Service Program**

Motion by Brian Norby/Heidi Hartz to authorize the Board of Education to provide a school food service program for the pupils attending the Johnson Creek Schools and to appropriate funds to be used for that purpose. Motion Carried.

**Resolution C: Transportation** 

Motion by Ryan Molley/Jennifer Tracy to authorize the Board of Education to purchase, operate, and maintain pupil transportation vehicles and to purchase liability insurance for such vehicles or to finance contracts for the use and services of student transportation vehicles. Motion Carried.

# **Resolution D: Tax Levy**

Motion by Dennis Schuh/George Nimm to set the tax levy at \$4,045,737 for the purpose of defraying the costs of operation and maintenance of the public schools and \$286,654 to repay non-referendum debt, \$1,647,201 for the purpose of repaying referendum debt and \$100,000 for Community Service Fund, for a total levy of \$6,079,592.
