Fund Raising Activities Involving the Schools

POLICY: 374

Any activity involving students and the raising of money or funds through soliciting shall be divided into one of two classifications: major or minor.

A major fund-raising activity shall be defined as any that requires students to go beyond the school campus into the community, the school district, or other expanded area to solicit for funds through sales. Any MS/HS school class or organization is restricted to just one major fundraiser per school year. Elementary school classes or organizations are limited to two major fundraisers per school year. All must have the prior approval of the district administrator who may schedule or set the conditions under which the activity is permitted.

A minor fund-raising activity shall be defined as any that allows students to solicit for funds through sales within the confines of the school campus. While this policy places no restrictions as to the number of minor fund raisers a class or organization may have, the activity must have prior approval of the building principal who may schedule and/or limit the number of minor fund raising activities a class or organization may have or set the condition(s) under which each activity is permitted.

Before granting approval to allow a fund-raising activity, the appropriate administrator shall consider each of the following criteria:

- 1. The purpose of the fund raiser must be consistent with the goals and objectives of the organization or class and the school;
- 2. The fund-raising activity will not bring undesirable or hidden costs either to the school district or to the class or organization;
- 3. The fund-raising activity will place no restrictions on the school program;
- 4. The best education of students involved in the fund-raising activity would not be adversely affected by their participation in the activity;
- 5. The goods, products, labors, efforts, etc. offered for sale should be of such quality and reasonably priced so as not to impact negatively on the school district, the class, or the organization;
- 6. The fund-raising activity shall not necessarily bind future classes or organizations or the school district to some course of action;
- 7. Any facet of the fund-raising activity--whether it be the activity itself, the product or labor solicited, or the cost--must not be in conflict with any provision of public law, board of education policy, or school code.
