Setting the 2012-13 levy and Review of the 2012-13 budget: Dr. Garvey presented the supporting information for the budget changes and the levy calculations.

Motion by Oneil/McCaffery to levy upon the property of the Johnson Creek School District the sum of \$3,574,918 for the purpose of defraying the costs of operation and maintenance of the public schools, \$200 for the charge back levy, \$48,994 for the purpose of repaying debt and \$20,500 for the Community Service Fund, for a total levy of \$3,644,612.
